Addressing obesity in the workplace

How employers can be part of the solution



Obesity is a chronic, progressive disease affecting over 40% of US adults

48% of Latinx adults

46.8% of Black adults

37.9% of White adults

The complexity of obesity and its association with other chronic diseases result in an estimated economic burden of **\$1.72 trillion**



● Nearly **\$480.7 billion** in direct healthcare costs

● **\$1.24 trillion** in indirect costs due to lost productivity

Reduce Stigma

Stigma about weight is a large barrier to action. How can you help create a more inclusive workplace culture?

→ **Increase awareness:**
Position obesity as a chronic disease, not a lifestyle failure

→ **Use people-first language:**
Person first, condition second: "A person with obesity" rather than "an obese person"

→ **Broaden diversity and inclusion training:**
Educate your workforce on weight bias and discrimination

→ **Accommodations:**
Ensure accessibility to proper equipment and facilities

Take Action

→ **Evaluate the costs of inaction:** Research and monitor the costs of obesity in your workplace

→ **Seek partnerships** or educational opportunities with obesity advocacy organizations

→ **Re-evaluate the effectiveness of your wellness programs** by implementing long-term evaluation of interventions and their impact on improvements in employee weight loss and health outcomes

→ **Assess and advocate for appropriate treatment** for the full spectrum of options to treat obesity, including medication, surgery, and comprehensive lifestyle intervention
